2. In order to facilitate the states in preparation of DPRs etc, an advertisement in newspapers for selection of State Implementation Consultants (SICs) was issued. Expressions of Interest (EOIs) were received and were considered by the Committee based on the criteria mentioned in the EOI and the information submitted by the firms. After an evaluation of expression of interest submitted by interested firms an indicative list of 12 firms has been shortlisted:

The State Government is advised to follow a transparent tender procedure and satisfy themselves about the technical and financial credentials of the consultancy firms. Moreover, the enlisted consultants shall not have any overriding priority compared to other suitable and eligible consultants that may be selected by the State Governments.

5. The State Governments/Urban Local Bodies may use the indicative list enclosed as reference. The financial bids etc are to be finalized after due process.
