

N.B- \* Chairman / Vice chairman

- (a) Where there is only one Member of Lok Sabha in a District, he / she may be nominated as Chairman of the Committee irrespective of the fact whether he / she is Speaker / Deputy Speaker, Lok Sabha or a Minister in the Union Council of Ministers.
- (b) Where there are more than one Member of Lok Sabha in a District, Speaker / Deputy Speaker, Lok Sabha or a Minister in the Union Council of Ministers, if there is any one of these amongst member, should be nominated as Chairman and other member(s) may be nominated as Co-Chairman of the Committee. If however, all are Members, one who is representing maximum geographical area / assembly segments of the District as a part of his / her Constituency should be nominated a Chairman and the other member(s) should be nominated as the Co-Chairman.
- (c) Where there is only one Member of Lok Sabha in a District and he / she is representing more than one District, he / she may be nominated as Chairman of the Committee in all Districts which he / she is representing (such situation is likely to be more in North-Eastern States where an M.P. is representing many Districts)
- (d) A Member of Parliament (Rajya Sabha) representing the States and exercising the option to be associated with the District Level Committees of the District (on first-come basis) should be nominated as Vice Chairman. All other Member(s) of Parliament should be nominated as Co-Chairman.
