No.5/47/2012-2LG4/649 In pursuance of the objective of ensuring satisfactory implementation of the projects and reforms under JNNURM including Urban Infrastructure and Governance (UIG), Basic Services to Urban Poor (BSUP), Urban Infrastructure Development of Small and Medium Towns (UIDSSMT) and Integrated Housing and Slum Development Programme (IHSDP) and to effectively liaise and coordinate with various agencies and organizations of Central and State Governments in satisfactory implementation of projects and reforms under JNNURM, the Governor of Punjab is pleased to constitute the District Level Review and Monitoring Committee (DLRMC) in each district of the State of Punjab as following:-

a	State Cabinet Minister (to be nominated by the State Government)	Chairman
b	Member Parliament (Lok Sabha) of the concerned district	Senior Vice-Chairman
c	Member Parliament(Rajya Sabha) of the concerned district	Vice-Chairman
d	All Member of the State Legislative Assembly of concerned districts	Member
e	Mayor/President of the concerned Municipal Corporation/Council	Member
f	Concerned Regional Deputy Director of the ULB	Member
g	Concerned Commissioner/ Executive Officer of the Municipal Corporation/ Councils.	Member
h	One Member from the reputed NGOs having urban experience nominated by the Ministry of Urban Development, Government of India	Member
i	One Professional from the field of Social Work/Social Science having urban experienced to be nominated by the Ministry of Urban Development, Government of India,	Member
j	One Representative of SC/ST and Women having urban experienced to be nominated by the Ministry of Urban Development, Government of India	Member
k	Concerned Deputy Commissioner	Member Secretary

2.0 The functions of the Committee would be as following:

- (i) Review Physical and Financial Progress of projects;
- (ii) Review Progress of Urban Sector Reforms;
- (iii) Review bottlenecks in implementation of reforms and projects and the way forward;
- (iv) Convergence of projects under UIG/UIDSSMT and BSUP/ IHSDP as well as convergence of other initiatives at the city/ district level with JNNURM; and
- (v) Guide the ULB(s) on the implementation of projects relating to infrastructure and services as well as implementation of reforms in urban areas.

3.0 The Committee may meet as often as may be required to achieve its objectives, but it shall meet atleast once in a quarter.

4.0 The committee would submit minutes of the meetings/ discussions held and its recommendations to the concerned ULBs, State Level Nodal Agency (SLNA) and the State Government. The SLNA would take action to upload the minutes on its website.

5.0 SLNA would monitor and ensure that action is taken on the recommendations of the Committee. The action taken report should be submitted by the SLNA to the State Government. The action taken report should also form the agenda of all meetings of the committee. If there are issues of significance in the action taken report, these may be brought to the notice of Ministry of urban Development and Ministry of Housing and Urban Poverty Alleviation, Government of India.

6.0 The Member Secretary of the Committee shall convene the meeting on the direction of the chairman. If the chairman is not present, the members who are present shall elect a chairman from amongst themselves to preside over the scheduled meetings.

7.0 The Punjab Municipal Infrastructure Development Company (SLNA) and ULBs concerned would assist the committee through the member secretary in the discharge of its function.
