3. Review bottlenecks in implementation of reforms and projects and the way forward.
4. Convergence of projects under Urban Infrastructure and Governance (UIG) / Urban Infrastructure Development Scheme for Small and Medium Town (UIDSSMT) and Basic Services for Urban Poor (BSUP) / Integrated Housing and Slum Development Project (IHSDP) as well as convergence of other initiatives at the city / district level with Jawaharlal Nehru National Urban Renewal Mission (JNNURM).

The Review and Monitoring Committees would have the following functions:


1. The committee should meet quarterly and conduct review of implementation of projects and reforms.
2. The committee will submit minutes of the meetings/discussion held and recommendations to the concerned Urban Local Bodies (ULBs) and State Level Nodal Agencies (SLNAs) and State Governments concerned.

3. The SLNA will ensure that minutes are uploaded on the web and copy is sent to Ministry of Urban Development (MoUD) and Ministry of Housing and Urban Poverty Alleviation (MoHUPA). The SLNA will also ensure that action is taken on the recommendations of the Committee and action taken report is submitted to the State Government and MoUD & MoHUPA. The action taken report must be on the agenda item of all the meetings of the Committee.

The Review and Monitoring Committees would meet once a quarter for reviewing the progress and would be the forum for sorting out inter-agency co-ordination issues.


