**PREAMBLE:**

In the letter read at (1) above, the Ministry of Urban Development (MoUD), Government of India (GoI) has informed the State to constitute District Level Review & Monitoring Committee (DLRMC) headed by the Honorable Members of Parliament to review and monitor the implementation of Projects and Reforms under JnNURM. The Guidelines outlining the objective, composition and functions of the Committee have been issued by the MoUD, GoI.

In accordance with the Guidelines, the KUIDFC has sent a proposal to the Government to constitute the District Level Review and Monitoring Committee to review and monitor the progress of the projects and reforms under JNNURM [the sub-missions of Urban Infrastructure & Governance (UIG) and Basic Services to Urban Poor (BSUP)] with the following Members:

1. All Members of Parliament (Lok Sabha) and also Members of Parliament (Rajya Sabha), who have given their choice from the district, will be members.
  2. All Members of State Legislative Assembly elected from constituencies within the District.
  3. Mayors/Chairpersons of the Municipal Corporations, Chairpersons of Municipal Councils and Municipal Commissioners/ Chief Executive Officers.
  4. Project Officer, DUDA or an officer from State Government/Regional Municipal Administration:
  5. One member from a reputed NGO to be nominated by the State Ministry.
  6. One professional from Social Work/Social Science to be nominated by the State Ministry.

7. One representative each of SC/ST and Women to be nominated by the State Ministry.

The members at Sl. No. 5, 6 and 7 would be required to have urban experience. The Chairman, Co-Chairman, Vice Chairman and Member-Secretary are to be nominated as per the MoUD's Guidelines.

The proposal has been examined in detail and hence this order.

- (i) Review Physical and Financial Progress of projects.
- (ii) Review Progress of Reforms.
- (iii) Review bottlenecks in the implementation of reforms and projects and the way forward.
- (iv) Convergence of projects under UIG/UIDSSMT and BSUP/IHSDP as well as convergence of other initiatives at the city /district level with JNNURM.

**Functions of the Committee:**

- (i) The Committee shall meet quarterly and conduct review of implementation of projects and reforms
- (ii) The Committee shall guide the ULB on implementation of projects relating to infrastructure & services as well as implementation of reforms.
- (iii) The Committee shall submit minutes of the meetings/discussion held and recommendations to the concerned ULBs and SLNAs and State Governments concerned.

- (iv) The State Level Nodal Agency (SLNA) shall ensure that minutes are uploaded on the web and copy send to MoUD and MoHUPA. The SLNA shall also ensure that action is taken on the recommendations of the committee and action taken report is submitted to the State Government, MoUD & MoHUPA. The action taken report must form part of the agenda of all the meetings of the Committee. If there are issues of significance in the action taken report, this may be brought to the notice of MoUD and MoHUPA.

The Member-Secretary shall convene the meeting of the Committee on the directions of the Honourable Chairman. The SLNA, BBMP and MCC shall assist the Committee through the Member Secretary in discharge of its function.
